HIGHLIGHTS

- HVPE's estimated NAV per share is \$19.99 (£14.92), a slight decrease of \$0.08 from 31 August 2017.
- Borrowing remains at zero, and the Company holds \$176 million of cash on its balance sheet.
- The Investment Pipeline of unfunded commitments is \$1.17 billion, a \$36 million decrease from 31 August 2017.
- The Company invested \$36 million and received \$32 million in realisations during the month.

Commitments and Investment Pipeline

The Company did not make new commitments to HarbourVest funds during September. HVPE's existing HarbourVest fund commitments continued to make new investments.

HVPE's Investment Pipeline (unfunded commitments) of \$1.17 billion decreased on a net basis by \$36.2 million during September based on capital funded and foreign currency movements. Of the total investment pipeline, \$940.3 million (80%) has been committed by HarbourVest funds to underlying funds.

Cash Invested

During September, HVPE invested \$35.8 million into HarbourVest funds, compared to \$39.8 million in August 2017. The largest investment was made to HarbourVest 2017 Global Fund, a global multi-strategy fund-of-funds, that funded several new investments.

NAV Growth

At 30 September 2017, HVPE's estimated NAV per share is \$19.99 (£14.92), a \$0.08 decrease in USD terms and a £0.60 decrease in sterling terms from the 31 August 2017 estimate of \$20.07 (£15.52). The decrease of 0.4% in US dollar terms compares to the FTSE All-World increase of 1.8% during September.

The decrease in the 30 September NAV resulted mainly from receipt of final 30 June valuations from the underlying partnership funds, negative foreign currency movement, and operating expenses of \$0.04 per share. This was partially offset by increasing valuations for publicly-traded companies (which represent approximately 18% of HVPE's investment portfolio value). During September, the euro depreciated 0.8% against the US dollar.

Realisations Received

HVPE received \$32.0 million in realisations from HarbourVest funds during September, compared to \$19.3 million in August. The largest sources of realisations included a global secondary fund and a global multi-strategy fund-of-funds, which distributed proceeds from multiple secondary investments and several direct co-investments.

Liquidity Events

During September, there were a total of 45 liquidity events across HVPE's underlying portfolio (compared to 39 in August and a last 12-month average of 36). These included 38 M&A events and seven IPOs. September IPOs included:

- US-based buyout-backed chemical company PQ Corporation (PQG), held in both the primary fund and secondary portfolios via Carlyle and CCMP Capital.
- China-based venture-backed second-hand luxury retailer Secoo Holding (SECO), held in the primary fund and secondary portfolios via IDG Capital Partners.
- US-based venture-backed television and video streaming service *Roku* (ROKU), held in the primary fund and secondary portfolios via Menlo Ventures.

MANAGING A LISTED PRIVATE EQUITY COMPANY

Throughout HVPE's ongoing cycle of Commitments, Investment, Growth, and Realisation, the Board (along with the Investment Manager) employs tools and policies to manage the risk and reward for the benefit of the Company's shareholders.

Credit Facility

HVPE currently has no drawings on its credit facility. At 30 September 2017, HVPE's cash (\$175.9 million) and available credit (\$500.0 million) total \$675.9 million. This represents 72% of commitments allocated to underlying funds and 58% of total commitments (compared to 73% and 56%, respectively, at 31 August 2017). The Rolling Coverage Ratio at 30 September 2017 is 110%. This reflects the sum of cash, available credit, and realisations expected to be received during the current financial year, taken as a percentage of the expected cash investments in HarbourVest funds over the current year plus the next two years. In considering forecast investments over a three-year period rather than total unfunded commitments, this calculation enables a more useful comparison of HVPE's coverage ratio relative to many of its peers.


Management of Foreign Currency Exposure

HVPE has exposure to foreign currency movements through foreign currency-denominated assets within the portfolio and through its unfunded commitments, which are long term in nature. The Company's most significant currency exposure is to euros. The Company does not actively use derivatives or other products to hedge the currency exposure.

ESTIMATED SHAREHOLDER BREAKDOWN at 30 September 2017




CURRENCY EXPOSURE (underlying partnership funds) at 30 September 2017



PORTFOLIO DIVERSIFICATION NAV

Consistent with HVPE's investment objective, the investment manager strives to manage risk through diversification within the portfolio. The charts illustrate the breakdown of HVPE's investment portfolio at 30 September:

Notes The diversification by net asset value analysis is based on the fair value of the underlying investments, as estimated by the investment manager. Diversification by stage, phase, and geography is based on the estimated net asset value of partnership investments within HVPE's fund-of-funds and company investments within HVPE's co-investment funds. Industry diversification is based on the reported value of the underlying company investments for both fund-of-funds and co-investment funds. Some of the funds held in HVPE have not been fully invested. The composition of investments by phase, stage, geography, strategy, and industry may change as additional investments are made and existing investments are realised. By phase, mature includes vintage years pre-2007, growth includes vintage years 2008 to 2012, and investment includes vintage years 2013 to 2017.

HarbourVest Global Private Equity Limited ("HVPE" or the "Company") is a Guernsey-incorporated, closed-end investment company which is listed on the Main Market of the London Stock Exchange and is a constituent of the FTSE 250 index. HVPE is designed to offer shareholders long-term capital appreciation by investing in a private equity portfolio diversified by geography, stage of investment, vintage year, and industry. The Company invests in and alongside HarbourVest-managed funds which focus on primary fund commitments, secondary investments and direct co-investments in operating companies. HVPE's investment manager is HarbourVest Advisers L.P.. an affiliate of HarbourVest Partners, LLC, an independent, global private markets asset manager with more than 35 years of experience.
