

HVPE ESTIMATED NAV PER SHARE UPDATE AT 30 APRIL 2023

- Estimated NAV per share of \$48.38 (£38.52); a decrease of 0.1% in US dollar terms over the month
 - 7% of Investment Portfolio valued at 30 April 2023 (representing the public companies in the portfolio)
 - 93% valued at 31 December 2022
- A net \$31 million was invested in April 2023

HarbourVest Global Private Equity Limited ("HVPE" or the "Company"), a FTSE 250 investment company with global exposure to private companies, managed by HarbourVest Partners, today announces its estimated Net Asset Value ("NAV") at 30 April 2023.

HVPE provides a complete private equity solution for public investors, managing the portfolio through four phases of the private equity cycle to create value: Commitments, Investment, Growth, and Realisation.

Commitments

During April 2023, no new commitments were made to HarbourVest funds. HVPE's Investment Pipeline (unfunded commitments) decreased by \$42 million from the prior month, following capital called for investments, as highlighted below, and foreign exchange movements. The Investment Pipeline totalled \$2.7 billion at 30 April 2023.

Investment

During April 2023, HVPE invested \$42 million into HarbourVest funds (compared to \$46 million in March 2023). The largest individual investment during the month was made to a 2021 vintage US-focused buyout fund.

Growth

At 30 April 2023, HVPE's estimated NAV per share was \$48.38 (£38.52), compared to the 31 March 2023 estimate of \$48.42 (£39.25). This represents a 0.1% decrease in US dollar terms over the previous month and was driven by valuation declines from the fund of funds part of the portfolio, partially offset by favourable FX movements.

The valuation breakdown of the HVPE portfolio as reported here is as follows: 7% actual 30 April 2023 (representing the public companies in the portfolio), and 93% actual 31 December 2022. Consistent with previous estimated NAV reports, valuations are also adjusted for foreign exchange movements, cash flows, and any known material events to 30 April 2023. This compares to 7% actual 31 March 2023 (representing the public companies in the portfolio), 90% actual 31 December 2022 and 3% actual 30 September 2022, used in the 31 March 2023 estimated NAV per share calculation.

Realisation

HVPE received distributions of \$11 million from HarbourVest funds during April 2023 (compared to \$38 million in March 2023). The largest source of proceeds came from a

2018 vintage global direct co-investment fund. During April 2023, there were a total of 15 known M&A transactions and IPOs across HVPE's underlying portfolio, compared to March's total of 10, and a last 12-month average of 19. These were broken down into 13 M&A transactions and two IPOs.

Balance Sheet and Credit Facility

During March 2023, HVPE initiated a \$200 million draw on its credit facility. These funds were received on 18 April 2023 and have been included in the accounting figures as at 30 April 2023.

At 30 April 2023, HVPE had \$600 million available on its credit facility. Borrowing at the HarbourVest fund level amounted to \$527 million, an increase of \$11 million from the previous month. HVPE's cash and cash equivalents (\$313 million) and available credit (\$600 million) totalled \$913 million.
