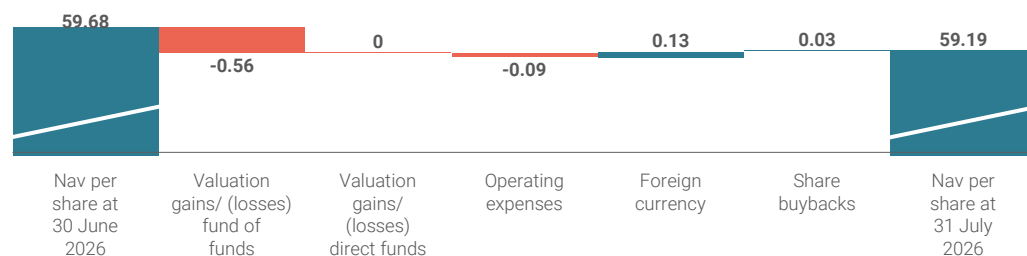

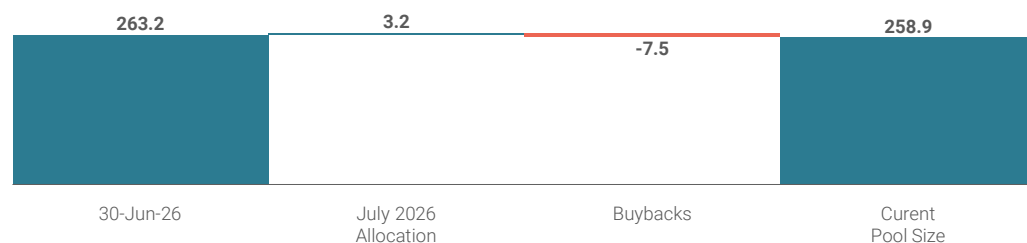
Commentary

At 31 July 2026, the estimated NAV per share was \$59.19 (£43.90), a decrease of 0.8% in US dollar terms and 2.5% in sterling over the prior month. The main underlying drivers of the USD NAV were negative public market and material events adjustments in the fund of funds portfolio. July saw negative net cash of \$3 million with distributions of \$11 million from the portfolio against \$14 million of capital calls. The Distribution Pool balance at 31 July was \$259 million, while share buybacks during the month totalled \$8 million.

Distribution Pool (movement through month) (\$)



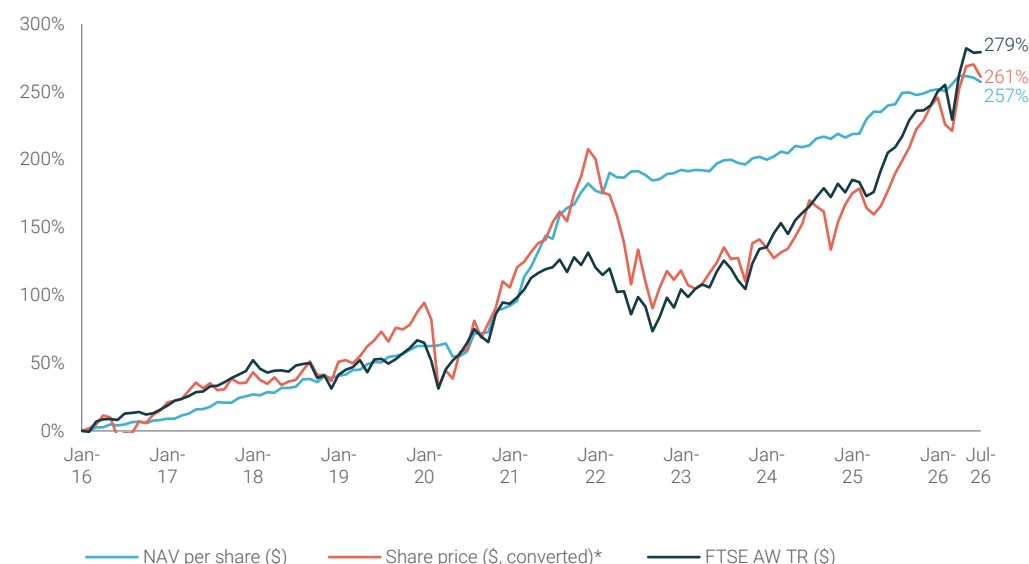

The Private Equity Cycle

Month ended 31 July 2026

HarbourVest Global Private Equity Limited ("HVPE" or the "Company") invests in and alongside HarbourVest-managed funds which focus on primary fund commitments, secondary investments and direct co-investments in operating companies. These in turn drive a steady pace of direct and indirect investment into private company opportunities. These investments develop and grow over a period of several years, before being exited. Proceeds from these distributions then provide the capital for new commitments and the lifecycle continues.

Investments (Investment Phase)

In July, the majority of capital calls from underlying partnerships (by value) were for buyout investments at 52%, with venture and growth equity investments representing a further 39%. Of the total amount called, 46% had a North American investment focus and 33% had a European investment focus.

Distributions (Mature Phase)

During July, there were a total of 46 M&A transactions and IPOs across HVPE's underlying portfolio, compared to June's total of 46, and a last 12-month average of 40. These were broken down into 39 M&A transactions and seven IPOs.

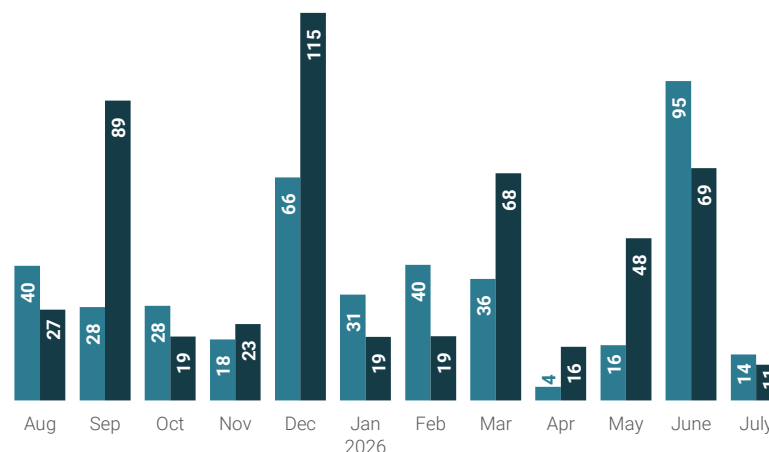

12 Month Cash Flow (\$m)

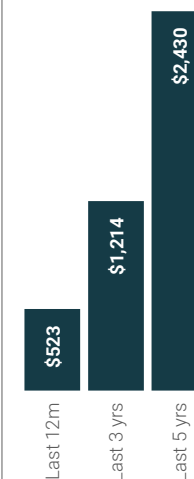

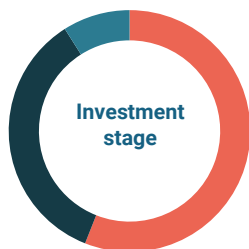
Historical Distributions* (\$m)



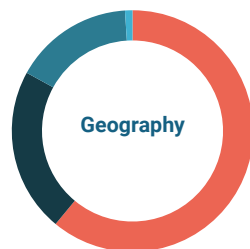

Consistent with HVPE's investment objective, the Investment Manager strives to manage risk through diversification within the portfolio.



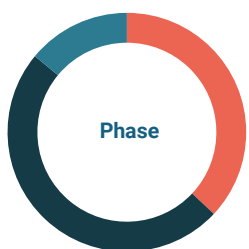

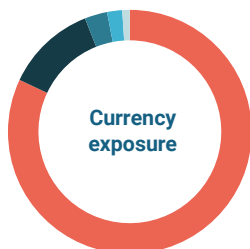

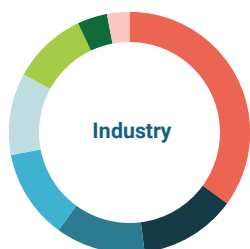

The diversification by net asset value analysis is based on the fair value of the underlying investments, as estimated by the investment manager. Diversification by stage, phase, currency and geography is based on the estimated net asset value of partnership investments within HVPE's fund of funds and company investments within HVPE's co-investment funds. Industry diversification is based on the reported value of the underlying company investments for both fund of funds and co-investment funds. Some of the funds held in HVPE have not been fully invested. The composition of investments by phase, stage, geography, strategy, and industry may change as additional investments are made and existing investments are realised. By phase, mature includes vintage years pre-2017, growth includes vintage years 2017 to 2021, and investment includes vintage years 2022 to 2026.

Managing HVPE

Credit facility

If future investments exceed distributions for a sustained period, it is important that HVPE is able to access funding as required to meet any shortfall. At 31 July 2026, HVPE had a cash balance of \$140 million and access to \$720 million on its credit facility.

HarbourVest Partners (“HVP”) Fund-level borrowing

Investment Pipeline and commitment ratios

The Board and Investment Manager make reference to three key ratios when assessing the Company’s commitment levels, as shown below.

Valuation Methodology:

HVPE carries its investments at fair value in accordance with US generally-accepted accounting principles. HVPE’s Investment Manager uses the best information it has available to estimate fair value. Fair value for private equity assets is based on the most recent financial information provided by the Investment Manager, adjusted for known investment operating expenses and subsequent transactions, including investments, realisations, changes in foreign currency exchange rates, and changes in value of public securities. The valuation breakdown of the HVPE portfolio as reported here is as follows: 7% actual 31 July 2026 (representing public company holdings), 5% actual 30 June 2026, and 88% actual 31 March 2026. Consistent with previous estimated NAV reports, valuations are also adjusted for foreign exchange movements, cashflows, and any known material events to 31 July 2026.
