HVPE ESTIMATED NAV PER SHARE UPDATE AT 31 OCTOBER 2023

- Estimated NAV per share of \$49.08 (£40.38); down 0.5% in US dollar terms over the month
 - 6% of Investment Portfolio valued at 31 October 2023 (representing the public companies in the portfolio)
 - 8% valued at 30 September 2023; remainder 86% valued at 30 June 2023
- A net \$43 million invested in October 2023

HarbourVest Global Private Equity Limited ("HVPE" or the "Company"), a FTSE 250 investment company with global exposure to private companies, managed by HarbourVest Partners, today announces its estimated Net Asset Value ("NAV") at 31 October 2023.

HVPE provides a complete private equity solution for public investors, managing the portfolio through four phases of the private equity cycle to create value: Commitments, Investment, Growth, and Realisation.

Commitments

During October 2023, HVPE made one new commitment to a global infrastructure and real assets fund. The Company's Investment Pipeline (unfunded commitments) increased by \$24 million from the prior month, following capital called for investments, as highlighted below, and foreign exchange movements. The Investment Pipeline totalled \$2.6 billion at 31 October 2023.

Investment

During October 2023, HVPE invested \$51 million into HarbourVest funds (compared to \$65 million in September 2023). The largest individual investment during the month was made to a 2020 vintage international multi-strategy fund of funds.

Growth

At 31 October 2023, HVPE's estimated NAV per share was \$49.08 (£40.38), compared to the 30 September 2023 estimate of \$49.31 (£40.42). This represents a 0.5% decline in US dollar terms over the previous month and was mainly driven by valuation decreases from the public market portion of the fund of funds portfolio.

The valuation breakdown of the HVPE portfolio as reported here is as follows: 6% as at 31 October 2023 (representing the public companies in the portfolio), 8% actual 30 September 2023 and 86% actual 30 June 2023. Consistent with previous estimated NAV reports, valuations are also adjusted for foreign exchange movements, cash flows, and any known material events to 31 October 2023. This compares to 10% actual 30 September 2023 (reflecting 7% public company holdings and 3% direct co-investments), and 90% actual 30 June 2023, used in the 30 September 2023 estimated NAV per share calculation.

Realisation

HVPE received distributions of \$8 million from HarbourVest funds during October 2023 (compared to \$38 million in September 2023). The largest source of proceeds came from a 2013 vintage global direct fund.

During October 2023, there were a total of 17 known M&A transactions and IPOs across HVPE's underlying portfolio, compared to September's total of 25, and a last 12-month average of 19. These were broken down into 15 M&A transactions and two IPOs.

Balance Sheet and Credit Facility

At 31 October 2023, HVPE had \$600 million available on its credit facility. Borrowing at the HarbourVest fund level amounted to \$558 million, an increase of \$7 million from the previous month. HVPE's cash and cash equivalents (\$95 million) and available credit (\$600 million) totalled \$695 million.
