

HVPE ESTIMATED NAV PER SHARE UPDATE AT 31 AUGUST 2023

- Estimated NAV per share of \$49.70 (£39.23); up 0.2% in US dollar terms over the month
 - 7% of Investment Portfolio valued at 31 August 2023 (representing the public companies in the portfolio)
 - o **79% valued at 30 June 2023; remainder (14%) valued at 31 March 2023**
- A net \$39 million invested in August 2023
- Pick up in exit activity sustained for second consecutive month, with 28 known M&A transactions and one IPO in August 2023

HarbourVest Global Private Equity Limited ("HVPE" or the "Company"), a FTSE 250 investment company with global exposure to private companies, managed by HarbourVest Partners, today announces its estimated Net Asset Value ("NAV") at 31 August 2023.

HVPE provides a complete private equity solution for public investors, managing the portfolio through four phases of the private equity cycle to create value: Commitments, Investment, Growth, and Realisation.

Commitments

During August 2023, no new commitments were made to HarbourVest funds. The Company's Investment Pipeline (unfunded commitments) decreased by \$51 million from the prior month, following capital called for investments, as highlighted below, and foreign exchange movements. The Investment Pipeline totalled \$2.6 billion at 31 August 2023.

Investment

During August 2023, HVPE invested \$51 million into HarbourVest funds (compared to \$10 million in July 2023). The largest individual investment during the month was made to a 2018 vintage US-focused buyout fund of funds.

Growth

At 31 August 2023, HVPE's estimated NAV per share was \$49.70 (£39.23), compared to the 31 July 2023 estimate of \$49.60 (£38.64). This represents a 0.2% increase in US dollar terms over the previous month and was mainly driven by valuation increases from the fund of funds portfolio.

The valuation breakdown of the HVPE portfolio as reported here is as follows: 7% actual 31 August 2023 (representing the public companies in the portfolio), 79% actual 30 June 2023 and 14% actual 31 March 2023. Consistent with previous estimated NAV reports, valuations are also adjusted for foreign exchange movements, cash flows, and any known material events to 31 August 2023. This compares to 7% actual 31 July 2023 (representing the public companies in the portfolio), 5% actual 30 June 2023 and 88% actual 31 March 2023, used in the 31 July 2023 estimated NAV per share calculation.

Realisation

HVPE received distributions of \$12 million from HarbourVest funds during August 2023 (compared to \$2 million in July 2023). The largest source of proceeds came from a 2011 vintage US-focused buyout fund of funds.

During August 2023, there were a total of 29 known M&A transactions and IPOs across HVPE's underlying portfolio, compared to July's total of 30, and a last 12-month average of 18. These were broken down into 28 M&A transactions and one IPO.

Balance Sheet and Credit Facility

At 31 August 2023, HVPE had \$600 million available on its credit facility. Borrowing at the HarbourVest fund level amounted to \$543 million, a decrease of \$28 million from the previous month. HVPE's cash and cash equivalents (\$182 million) and available credit (\$600 million) totalled \$782 million.
